Andrew Titen made a motion to approve the April 26, 2023, Meeting Minutes, with revisions to the spelling of "Denise" under the Guests Present section. Chris Wojcik seconded the motion. **All in favor, motion passed.**

VI. NEW BUSINESS

- A. Approval of up to \$10,000 per Irrigation Repair
 - Suzanne Fernandez presented the request.
 - A report has been prepared for the grounds committee that includes all information on the deficiencies with the irrigation system.
 - Andrew Titen made a motion to give blanket permission to the Grounds Committee to approve any proposal for irrigation work up to \$10,000. Gary Lopez seconded the motion. All in favor, motion passed.
- **B.** Fieldstone Top Choice Bid for Burrington Park
 - Suzanne Fernandez presented the bid for fire ant extermination.
 - Fieldstone: \$570.
 - Andrew Titen made a motion to accept the bid from Fieldstone for fire ant removal. Chris Wojcik seconded the motion. **All in favor, motion passed.**
- **C.** Fieldstone Mainline Leak Repair Bids
 - Suzanne Fernandez presented the bids for mainline leak repairs.
 Main Line breaks along West Village Dr by Chardonnay
 - Fieldstone: \$1,325. Invoice #19723
 - Fieldstone: \$1,322. Invoice #19797
 - Andrew Titen made a motion to retroactively approve the repairs and the costs associated. Chris Wojcik seconded the motion. All in favor, motion passed.
 Main Line break at Sussex and Attley
 - Fieldstone: \$1,275. Invoice #19836
 - Andrew Titen made a motion to retroactively approve the repairs and costs associated. Jessica Magrill seconded the motion. **All in favor, motion passed.**

Sprinkler system rework in front of Cypress Trace

- Fieldstone: \$1,370. Proposal #15636.
- Andrew Titen made a motion to accept Proposal #15636 from Fieldstone. Marlene Harper seconded the motion. **All in favor, motion passed.**
- D. Cross Creek Herbicide Treatment Bid
 - Suzanne Fernandez presented the bids for herbicide treatments.
 - Ponds 1,2,3, and 7 will be herbicidally treated to target high growth vegetation.
 - Cross Creek: \$4,931.80
 - Andrew Titen made a motion to accept the proposal from Cross Creek, with revisions to the proposal so that it lists Pond 2 and includes details on the herbicide products used. Chris Wojcik seconded the motion. **All in favor, motion passed.**
- E. Accurate LED Revised Lighting Bid for Walbrooke and Sussex
 - Suzanne Fernandez presented the bid for lighting.
 - Accurate LED Bid revised to \$11,330. Proposal #1506.
 - Andrew Titen made a motion to approve the revised Proposal #1506 from Accurate LED. Jessica Magrill seconded the motion. **All in favor, motion passed.**
- F. Playground Equipment Pressure Washing
 - Suzanne Fernandez presented the bids.
 - Rainmaker: \$465
 - Andrew Titen made a motion to approve the proposal from Rainmaker. Chris Wojcik seconded the motion. **All in favor, motion passed.**

VII. REPORTS FROM COMMITTEES:

PHASE III SPECIFIC:

- A. Financials
 - Andrew Titen gave the report.
 - \$384,000 excess cash at April 30th.
 - Andrew proposed the Board put 52% of this excess, or \$200,00 in one-year CDs. Since they are currently paying 5% in interest, the Board only earns 1.3% interest at the bank. This would generate an additional \$7,380 in interest in one year.
 - Andrew Titen made a motion to invest \$200,000 in one-year CDs to generate an additional \$7,380. Suzanne Fernandez seconded the motion. All in favor, motion passed.

VIII. NEXT MEETING:

The next regular board meeting will be held at 7:00 p.m. on Wednesday, June 28, 2023 at the Carrollwood Cultural Center, 4537 Lowell Rd.

IX. ADJOURNMENT:
