  - Suzanne Fernandez made a motion to approve the bid from Fieldstone for mulching for \$11,592. Andrew Titen seconded the motion. **All in favor, motion passed.**
  - Suzanne Fernandez made a motion to approve the bid from Fieldstone for lateral leak irrigation repairs for \$5,641. Andrew Titen seconded the motion. All in favor, motion passed.
  - Suzanne Fernandez made a motion to approve the bid from Fieldstone for repairs to broken rotor and spray heads for \$9,937. Andrew Titen seconded the motion. **All in favor, motion passed.**
  - Irrigation Repairs: Rotors and Lateral Breaks: 1,049
  - Suzanne Fernandez made a motion to approve the bid from Fieldstone for rotor and lateral leak irrigation repairs for \$1,049. Andrew Titen seconded the motion. All in favor, motion passed.
